# What do I need to know about the Training Provider market?

The following summary statistics have been taken from market research reports and reliable resources that the Information Service uses to compile industry information. They should give you an indication of how your industry is faring at present and whether there is demand for your type of business:

- ♦ The prioritisation of vocational education has led to enhanced support for vocational and technical apprenticeships. The review into whether to pause or delay the complete roll out of T Level courses will create some uncertainty for the sector, while the impact of reforming the apprenticeship levy won't be clear for a while. Moreover, the number of people aged between 16 and 25 is forecast to rise, which will support industry demand, as this age group represents the industry's main demographic. Industry revenue is forecast to grow at a compound annual rate of 1.8% over the five years through 2029-30 to reach £1 billion. (IBIS World, *Technical & Vocational Education in the UK*, July 2024).
- Over the five years through 2024-25, revenue is expected to increase at a compound annual rate of 2.1% to £4.1 billion. The numerous benefits of online education and training (e.g. reduced learning and development costs, time savings and flexibility and promotion of continuous development) have spurred growth. The rise in student numbers has supported demand for additional training courses for those looking to boost their grades. (IBISWorld, Online Education & Training in the UK, July 2024).
- ↑ The global IT training market was valued at \$30,386.35 million in 2022 and is estimated to grow to \$42,430.46 million in 2027. This will create an incremental growth opportunity worth \$12,044.11 million between 2022 and 2027, which translates to around 40% of the market size in 2022. With limited growth opportunities, gaining market share from competition will be an important lever to drive growth for market participants. (Technavio, Global IT Training Market, 2023-2027).
- Revenue in the Professional Certificates market is projected to reach £212.70m in 2024. Revenue is expected to show an annual growth rate (CAGR 2024-2028) of 4.55%, resulting in a projected market volume of £254.10m by 2028. In the Professional Certificates market, the number of users is expected to amount to 1.8m users by 2028. (Statista, Professional Certificates in the UK, March 2024)
- ◆ The national organisation for this industry is <u>Skills Development Scotland</u>. Other industry bodies include the <u>Learning and Work Institute</u>, <u>Chartered Institute of Professional Development</u>, <u>Scottish Training</u> <u>Federation</u>, the <u>Association of Employment and Learning Providers</u> and the <u>Learning & Performance</u> <u>Institute</u>.

## How can I find out about my competitors?

Immediate competition will be from other businesses in your local area. There are several online directories which can be used to find company information and generate lists easily and at no expense. Many Local Authorities also publish local business directories on the web. Below are some key web resources:

- General business directories such as <u>Yell</u>, <u>Thomson Local</u> or <u>Google Maps</u>
- Trade specialists like <u>EuroPages</u> (European directory), <u>The Wholesaler</u> or <u>Free Index</u>
- Business to business (B2B) specialists such as <u>Kompass</u>

Likewise, your local Chamber of Commerce may publish a members' directory; find your local Chamber on the Scottish Chambers website.

Once you've identified who your competitors are, the next step is to gather information on the way they do business. Which services do they provide? How do they market themselves? How much do they charge?

To learn about your competitors:

- Look for articles or adverts in local newspapers, trade press and directories.
- ◆ Try to read their marketing material; if the company has an online presence, visit the company's website as a first port of call. Not only does it give you a better understanding of the company's activities, it can also offer a wealth of information such as a company history or staff biographies, as well as the company's partners or suppliers
- Search for information on limited UK companies via the <u>Companies House</u> website
- Gain an insight into your competitor's performance using credit checks and the accounts that limited companies are required to submit to Companies House each year.

- <u>Scottish Government Statistics</u> provide accurate and up-to-date statistics on Scotland, covering population, health, education and housing.
- ◆ <u>The Scottish Household Survey</u> provides information on the structure, characteristics, attitudes and behaviour of Scottish households, both at a national and local level.
- Office for National Statistics (ONS) is the recognised national statistical body for the UK. ONS covers a
